Please read before filling out the request for your tax information

In order for the 7th Street Casino to release this information, you are required to submit a signed “W2G, 1099, or Win/loss statement Request Form”. Only official request forms will be accepted for processing. You are also required to show proper approved photo identification before receiving the requested forms. You are required to obtain a notary public before mailing the form back to 7th Street Casino for processing. It will take approximately 10 business days to submit either walk-in or phone requests. (Only during tax season)

Please note: The tax statement request is only for 7th Street Casino Players Card Members and those individuals who had a W2G or 1099 gambling winnings. 1099's are automatically mailed out Jan 31st to the address 7th Street Casino has on file. For more information regarding the claiming and filling of gambling winnings, guests are encouraged to contact the IRS or their tax advisor.

What information is needed to be completed on the form?

1. Name-First and Last name. Printed Legibly. One form per customer.
2. Social Security Number-the SS# of the person requesting the tax statement (not-applicable if a 1042-S is being requested)
3. Mailing Address- to verify that the information in our system is correct
4. City/State/Zip Code
5. Telephone number
6. Players club Account Number (Not necessary if you don't know it)
7. Date of Birth- the birth date of the person requesting the form. This allows us to verify the correct information
8. Tax forms requested-W2G, Win/Loss, 1099. Indicate the gaming year and type of tax statement you are requested. The release statement must be signed by the account holder in order to process
9. For mail in requested Forms-You are required to obtain a notary Public before mailing the forms back to 7th Street Casino.
10. Copy of State/Gov't Issued ID
